

**GLADE WATER WORKS
WATER USERS AGREEMENT**

This agreement, between Glade Water Association, a nonprofit corporation, organized and existing under and by virtue of the laws of the State of Mississippi, hereinafter called the Association, and the undersigned member of the Association, hereinafter called the Member.

WHEREAS, the Member desires to purchase farmstead and domestic water from the Association, and to enter into a water users' agreement as required by the by-laws of the Association. NOW, THEREFORE, in consideration of the mutual covenants, promises, and agreements herein contained, it is hereby understood and agreed:

The Association shall furnish, subject to the limitations hereinafter provided for, such quantity of water for domestic and farmstead purposes as the Member may desire in connection with his occupancy of the following described property owned/ rented by him in Jones County Mississippi:

The Member has paid and the Association acknowledges receipt of the following items prior to execution of this agreement.

The Member shall install and maintain at his own expense a service line which shall begin at his property line and extend to the dwelling and other portion of his premises. The Member's service line shall connect with the distribution system of the Association at the nearest place of desired use by the Member, provided the Association has determined in advance that the Association water system is of sufficient capacity to permit delivery of water at that point. The Association shall have final jurisdiction in any question of location of any service line connection to its distribution system; shall determine the allocation of water to Members in the event of a water shortage.

The Association shall purchase and install a cut-off valve and may also include a water meter in each service. Such cut-off valve and meter shall be installed at a point on the system designated by the Association. The Association shall have exclusive right to use such cut-off valve and water meter and to turn it on and off. Only one residence or business is allowed per meter.

The Member shall pay for such water at such rates, time and place as shall be determined by the Association. The failure of a Member to pay water charges duly imposed shall result in the automatic imposition of the following penalties:

- A. Non-payment within thirty (30) days from the due date will result in the water being shut off from the Member's property. In the event it becomes necessary for the Association to shut off the water from a Member's property, a fee of \$50.00 will be charged for a reconnection of the service.
- B. Non-payment for sixty days after original due date will allow the Association, in addition to all other rights and remedies, to terminate the Member's Membership, and in such event, the Member shall not be entitled to receive, nor the Association obligated to supply any water under this agreement.

By executing this agreement, the applicant:

The applicant agrees that they have followed the guidelines set forth by the State Department of Health regarding onsite wastewater disposal.

- A. The applicant agrees to follow all Services Rules and Regulations set forth by the Association.
